Deposit check will be shredded after the pool has been returned, checked and found to be clean, dry, neatly repackaged and damage free. Rental payment is due whether you use the pool for labor or not.

### Agreement

The following represents the agreement between Labor of Love Childbirth Services (lessor) and \_\_\_\_\_  
\_\_\_\_\_ (lessee).

1. I do hereby acknowledge and agree that said lessor would lease the labor pool identified in this rental contract to me, the lessee.
2. Lessee understands that the rental price, \$200 for the Professional Birth Pool in a Box and optional \$25 Manhattan delivery fee for a tub, \$25 pick up of tub, on a per birth basis of a period of approximately 48 hours, depending on the length of your labor.
3. Lessee agrees to pay lessor for the shipping and handling charges for receiving and returning the labor pool if applicable.
4. Lessee acknowledges that this agreement is non-transferable.
5. Lessee acknowledges that the labor pool rental is specifically limited to indoor use.
6. Lessee agrees to take full responsibility for the manner in and purpose for which said labor pool is used.
7. Lessee agrees to contact lessor within about 8 hours of baby's birth to arrange labor pool return. Please call between the hours of 8am - 8pm.
8. Lessee agrees to return the labor pool to lessor undamaged, clean, dry and neatly packed following its use. Lessee agrees to pay for the return shipping and/or agrees to physically return the rented labor pool within 24-48 hours of birth, have prearranged the \$25 pickup fee in advance or lessee will be charged an additional \$75 per week.
9. Lessee agrees to pay full retail price for the replacement or repair of rented labor pool in the event that it is damaged, not returned to lessor, or rendered unusable while in lessee's possession.
10. Lessee understands that there will be no reduction in the rental fees if the labor pool is unused during the rental period, if the labor pool is returned before the birth or before the end of the rental period.
11. Lessee understands that the rental fee is nonrefundable, and that no portion of the rental fee will be refunded.
12. Lessee agrees to release and hold harmless lessor and/or any agent thereof, its members, employees, associates, and affiliated manufacturers from any and all responsibility or liability for maternal complications, infant mortality or morbidity, or injury to any or all persons in connection with the use of rented labor pool that may occur before, during, and/or after labor and/or birth in the labor pool provided by the lessee.
13. Lessee specifically holds lessor harmless from any claims made by third parties, as well as any damage or injury to property occasioned by the use of the labor pool during the rental period or while the labor pool is otherwise in the possession of the lessee, and further more agrees to indemnify lessor for any and all liability or expenses including attorney fees, incurred by lessor occasioned by the use of the labor pool during the rental period or while the labor pool is otherwise in possession of the lessee.
14. A non-refundable rental fee (\$200) and security deposit (\$375) are required to reserve the labor pool.
15. Cancellation for labor pools will be refunded less a \$75 processing fee ONLY if cancellation is received 2 weeks prior to lessee's due date.
16. Full payment is due before labor pool can be picked up or delivered.
17. In the event that the baby arrives before the tub is delivered, lessee will be refunded less a \$75 processing fee.
18. Lessee understands the cancellation policy and refund policy.
